

MONTHLY DISTRIBUTION DATE INFORMATION FORM

This Monthly Distribution Date Information Form (the "Information Form") is being provided by Wells Fargo Bank, National Association, as trustee (the "Trustee") pursuant to Section 5.04(c) of the Indenture of Trust, dated as of December 1, 2012 (the "Indenture"), between the Arkansas Student Loan Authority (the "Authority") and the Trustee. All capitalized terms used in this Information Form and not otherwise defined shall have the same meanings as assigned to such terms in the Indenture.

The Authority has provided a Monthly Distribution Date Certificate to the Trustee. In reliance upon the information and the Authority's direction contained therein, the Trustee shall make the following deposits and distributions in the following order of priority, to the Persons or to the account specified below by 3:00 p.m. (New York City time) on January 25, 2017 (the "Monthly Distribution Date"), to the extent of (a) the amount of Available Funds received during the immediately preceding Collection Period in the Collection Fund (or, if necessary, other Available Funds on deposit in the Collection Fund as provided in Section 5.04(c) of the Indenture) (viz., the sum of \$1,965,214.00), (b) the amount transferred from the Department Special Allowance Payment Rebate Fund pursuant to Section 5.06 of the Indenture (viz., the sum of \$0.00), (c) the amount transferred from the Reserve Fund pursuant to Section 5.05(b) and (c) of the Indenture (viz., the sum of \$324.70), and (d) the amount transferred from the Capitalized Interest Fund pursuant to Section 5.03 of the Indenture (viz., the sum of \$0.00).
